Circular Regarding New Amendments in The Motor Vehicles Act

Dear Parents

As per the stringent orders by the Hon'ble Additional Director General of Police, (ADGP) Traffic Road Safety, Punjab, the school students (Below 18 years of age) are strictly prohibited to ride a two-wheelers/ four wheelers (Activa, scooter, bike, or car) from 1st August 2024. As per the new amendments in the Motor Vehicles Act (Amendment 2019), if any under aged student/driver is caught riding a geared/gearless vehicle with more than 50 cc capacity, the owner on whose name the vehicle is registered (or parents) will be sent to imprisonment up to three years and a fine of Rs. 25,000 will be imposed. In case the under aged driver borrows the geared two-wheeler or four-wheeler from anyone else, then also the owner of the vehicle will be punished. This is absolutely a thoughtful decision to curb the rash driving and protect the precious lives of the students.

Therefore, it is imperative for all parents and students to abide by the Road safety rules religiously. The students of age group 16-18 years who have a valid underage driving license are allowed to use only the gearless vehicle with less than 50 cc capacity and speed of 30-40 km per hour as per the Motor Vehicle Act. The ISI marked helmet is also compulsory for such children. If any child flouts the order, and brings Activa or the above mentioned vehicles, the school will not allow them to park inside or outside the school premises. Moreover, the school will not be held responsible for any action taken by the State Administration against such students.

The school always discourages the use of self-conveyance wherein the students ride on gearless/geared vehicles and involve in rash driving. The safety and security of students is our utmost priority and hence, all parents are encouraged to avail the school transportation facility for ensuring the optimal road safety and protection for our stakeholders.

The school seeks for your support and cooperation for ensuring the active implementation of the new regulations of Motor Vehicles Act. We further urge you to contribute to the State Administration's campaign for spreading Road safety awareness.
